Financial Policies

- Tuition and childcare rates are published on the Rate Sheet and our website. Rates are calculated for the entire school year and then divided into equal monthly payments for your convenience. Families, who pay their tuition by cash, check or debit card will receive a discounted rate. Payments are accepted on a monthly basis. There are no reductions for vacations and holidays. Please indicate the payment plan you are selecting

Regular Monthly Payment Option

12 Month (June – May: \$476)

- Payments are due on the first of the month. A late charge of \$35.00 per month will be assessed if received after the 5th. When an account is 5 weeks delinquent, parents will be requested to withdraw the child from the school. **Statements will not be mailed** unless there is a past due amount owed on the account. *A \$35.00 service charge will be assessed on all returned checks.*
- All withdrawals, whether before the school year begins or during the year, must be made in writing and shall be effective when such notice is delivered to the school office. If a student leaves for any reason, or enters after the school year has begun, the charges are pro-rated on a quarterly basis as outlined on the Financial Rate Sheet. Unpaid balances over 35 days may be subject to collections.

Behavioral Standards

Students are expected to maintain a high standard of personal behavior. Foothill Christian School reserves the right to suspend or expel students whenever school privileges are abused, infractions are repetitive in nature, or when conduct does not conform to Christian standards set by FCS.

Conciliation Agreement

As a Christian ministry we believe that the Bible (Matt. 5:25, I Cor. 6:1-7) commands believers to make every effort to live at peace and to resolve disputes with each other in private or within the church. Therefore any unresolved dispute arising out of the relationship between the school and the home shall be resolved with assistance of a Christian conciliation service through mediation or as a last resort through legally binding arbitration. Should legal action, for any reason, be taken against FCS or any employee or agent thereof, and the school or its agent not be found at fault, the parent/guardian agrees to pay all attorney fees, court fees, damages or other costs that FCS or its agent should incur to defend itself against such action.
