The Foothill Christian School Band Program is offered to elementary students in 3rd – 8th grades.

Basic Components:

1. Private Instruction (Elementary) – ½ hour private lesson per week.
2. Sectional (Junior High) – 1 hour brass, flutes, clarinets, saxes, percussion per week.
3. Band Class (ALL Grades) – 1 hour band ensemble per week

Schedules:

Band Registration and Tuition Payment:

Registration Fee: \$25 annual fee. Enrollment is on a yearly basis (Sept. – May)

Band Tuition: \$810 annual tuition. Monthly Payment Plan = \$90/mo. (Sept. – May)

Instrument Loaner Program: \$25 annual maintenance fee (No monthly fee)

Available on first come basis.

Payment Policy: Monthly fees are due to the office by the first of the month. If student withdraws, charges are pro-rated on a quarterly basis. Payment is not required for the entire year, but is required for the entire quarter in which the child has attended band. Withdrawal must be made in writing and is effective at the end of the quarter. **Make checks payable to FCS.**

The Foothill Band Instrument Use Program is offered to students currently enrolled in the Elementary or Junior-High Band Program.

BAND INSTRUMENTS AVAILABLE FOR USE:

1. Woodwind Instruments: Flute, Clarinet, and Saxophone
2. Brass Instruments: Trumpet, Trombone, and Baritone
Note: Percussion Instruments available for use at school only.
3. String Instruments: Violin, viola, Cello

BAND INSTRUMENT USE POLICY:

Selecting an Instrument: Instruments will be provided to students based upon availability.

Instrument Maintenance/Repair Fee: \$25.00 annual fee, required at time of registration.

Payment Policy: The annual maintenance/repair fee will provide for minor repairs required during the year on the student's instrument. Students are responsible to keep their instrument in good working order and keep the instrument stored in its case when not in use. Problems with the instrument should be reported to the band director. Parents will be charged the full replacement cost for instruments lost, stolen or seriously damaged. Include the annual maintenance/repair fee with band tuition and registration fee with band tuition and registration fees at the time of enrollment.
