We allow a 30-minute grace period before the start of school and 15 minutes after 3:00 PM for pick up without an additional charge.

If you need care before 8:00 AM and/or care after 3:15 PM, you should select the Extended Day Plan.

There is a \$1.50 per minute charge for picking up after 3:15 PM.

The Extended Day Plan is open from 6:30 AM - 6:00 PM. There is a \$1.50 per minute charge if picked up after 6:00 PM.

All tuition payments must be made via Brightwheel, the office will not be accepting payments. There is no service fee for a bank transfer. When using a debit or credit payment you will incur a 2.9% service fee. (Rate subject to change.)

Tuition is set on a standardized monthly rate considering that some months have less days while other months have more days (including holidays and non-holiday school closures).

I have read and fully understand the Financial Agreement of Foothill Christian Preschool and will abide by the terms of the agreement. I will be responsible to meet my financial obligation to the preschool. I understand that the monthly payments are due the 1st of each month. A late fee is applied after the 5th of every month.

FREQUENTLY ASKED QUESTIONS

When is tuition due?

Tuition is due by the 1st of the month and is late if paid after the 5th. A late charge of **\$55.00** will be assessed on the unpaid balance of an account after the 5th of each month. If tuition is not paid by the 20th of the current month, your child may not return until your account is current. A parent will be asked to withdraw the child from school if payment is late on a consistent basis. Unpaid balances will be subject to collections.

What happens if I pick up my child late?

Please make every effort to be on time. If you are on the Half Day Plan you will be charged \$1.50 per minute after 12:15 PM, Regular Day Plan \$1.50 per minute after 3:15 PM, and Extended Day Plan \$1.50 per minute after 6:00 PM.

Are there tuition reductions if my child is sick, on vacation, or Covid related?

We will be unable to issue credit for illness or any other type of absence. The only credit given will be vacation credit that has been earned. Vacation credit is offered to 5-day per week students who have been enrolled for the entire year. After 12 months, 5-day per week students qualify for one-week vacation credit. When your child has been enrolled for two years (in the 5-day program) you qualify for two weeks. Every subsequent year remains at two weeks' vacation credit and must be taken in the summer. Vacation credit is not available for our 2 & 3 day per week students.

If it is necessary to withdraw my child from school how much notice does the school need?

Our policy requires that a <u>two-week notification</u> be submitted in writing when withdrawing your child. Families who fail to notify the office will be charged for the two weeks. Once withdrawn, families who decide to come back the same year must pay a new re-registration fee.

When my 2-year-old child is potty trained when is the extra fee eliminated?

To eliminate the not potty-trained fee, your child must be fully trained and in underwear all day for one month without accidents.

Why do you charge more for a 2-year-old or young 3-year-old class?

The ratio in these classes is six children to one adult. In our older classrooms, the ratio is twelve children to one adult.

How much will the cost be for an extra day?

An extra day is only available if prior arrangements have been made and there is room for your child. The extra cost is \$67.00 per day for the Extended Day Plan, \$61.00 for the Regular Day Plan, and \$53.00 for the Half-Day Plan.

How much does it cost if a Regular Day student needs Extended Day care for one day?

The cost is \$28.00 per day.

Are there discounts for additional siblings?

Tuition rates are set on a per pupil cost, there are no discounts for siblings who attend the school or preschool.

Do I receive a receipt after every payment?

You can access and download your monthly receipts, statements and even your annual tax summary directly from your Brightwheel account.

How do I order a hot lunch?

Hope's Italian Catering handles our hot lunch program. Lunch fees are paid directly to the caterers through an online account. View menus and order lunch online at: myschoolaccount.com. To enroll in the online lunch program, you will need your student ID number which is found on your child's Brightwheel profile page.
